

ORDINANCE NO. 2020 - 8

AN ORDINANCE PROVIDING FOR THE COMPENSATION OF APPOINTED OFFICIALS AND CERTAIN OTHER EMPLOYEES OF THE CITY, REPEALING CERTAIN ORDINANCES AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Willowick, Ohio feels it to be in the best interest of the city and to the orderly operation of all departments of the city to adjust the compensation of appointed officials and certain other employees.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOWICK, LAKE COUNTY, STATE OF OHIO:

SECTION 1. That the Officials and certain other employees listed below shall be paid bi-weekly compensation for the period commencing with the first pay period of 2020 and in accordance with the following existing rates of pay, respectively:

- Fire Chief. the sum of Four Thousand Sixty-eight and 37/100 Dollars (\$4,068.37);
- Police Chief. the sum of Four Thousand Eighty-eight and 51/100 Dollars (\$4,088.51);
- Finance Director. the sum of Three Thousand Eight Hundred Ninety-seven and 46/100 Dollars (\$3,897.46);
- Service Director. the sum of Three Thousand Two Hundred Sixty-five and 49/100 Dollars (\$3,265.49);
- Recreation Director. the sum of Three Thousand One Hundred Seventy-nine and 51/100 Dollars (\$3,179.51);
- Chief Housing & Zoning Inspector. The sum of Two Thousand Seven Hundred Eighty-seven and 62/100 Dollars (\$2,787.62);
- Law Director the sum of Two Thousand Twenty-seven and 33/100 Dollars (\$2,027.33);
- Prosecutor. the sum of Eight Hundred Eighty-three and 32/100 Dollars (\$883.32);
- Safety Director the sum of Six Hundred Forty-three and 54/100 Dollars (\$643.54);
- Payroll/Finance Officer the sum of One Thousand Six Hundred Seventy-three and 86/100 Dollars (\$1,673.86) to Two Thousand Two Hundred Thirty and 77/100 Dollars (\$2,230.77);

- Public Communications the sum of Eighty-six and 21/100 Dollars (\$86.21);
- Electrical Inspector (P/T) the hourly rate of Twenty-six and 15/100 Dollars (\$26.15);
- Senior Citizens Coordinator the sum of One Thousand Six Hundred Eighty-one and 41/100 Dollars (\$1,681.41);
- Facility/Program Coordinator the hourly rate of Nineteen and 49/100 Dollars (\$19.49);
- Finance Assistant/Accountant the hourly rate of Sixteen and 77/100 Dollars (\$16.77) to Twenty-one and 75/100 Dollars (\$21.75);
- Asst. Housing Inspector. the hourly rate of Fifteen and 38/100 Dollars (\$15.38) to Twenty and 71/100 Dollars (\$20.71) limited to a bi-weekly maximum of Fifty (50) hours;
- Asst. Senior Citizens Coordinator. .. the hourly rate of Fourteen and 07/100 Dollars (\$14.07) limited to a bi-weekly maximum of Forty-eight (48) hours;
- Senior Center Attendant..... the hourly rate of Ten and 25/100 Dollars (\$10.25) to Twelve and 95/100 Dollars (\$12.95) limited to a bi-weekly maximum of Fifteen (15) hours.

SECTION 2. That all ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. All formal actions of this Council concerning the passage of this Ordinance were adopted in an open meeting, and that all deliberations of this Council, or any of its Committees, which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 3.12 of the Charter of the City of Willowick and Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willowick and further, provides for the usual daily operation of all of the municipal departments; wherefore, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
