

**ORDINANCE NO. 2020 - 25**

**AN ORDINANCE AUTHORIZING AN ADDITIONAL HOURLY STIPEND OF \$6.00 PER HOUR FOR WEEKEND, NON-HOLIDAY SHIFT WORK TO THE PART-TIME, NON-SALARIED MEMBERS OF THE FIRE DEPARTMENT OF THE CITY OF WILLOWICK, BETWEEN MEMORIAL DAY AND LABOR DAY OF 2020, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the establishment of an additional hourly stipend for part-time, non-salaried members of the Fire Department during the weekend, non-holiday summer shifts between Memorial Day and Labor Day of 2020, will assist and ensure the City of Willowick Fire Department's necessary manpower and services to be provided to the residents;

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Willowick, County of Lake, and State of Ohio:

**Section 1.** That the part-time, non-salaried members of the City of Willowick Fire Department for weekend, non-holiday shift work between Memorial Day, May 25, 2020, and Labor Day, September 7, 2020, are hereby authorized to receive an additional hourly stipend of \$6.00 per hour.

**Section 2.** That for purposes of this Ordinance, weekend, non-holiday shift work shall be defined as commencing Saturday at 6:00 a.m., and continuing through to the immediately following Sunday, at 6:00 p.m., with a maximum total of thirty-six (36) hours, and exclusive of any holidays which may fall within these time parameters.

**Section 2.** That all Ordinances and parts thereof in conflict with the provisions of this Ordinance are hereby repealed.

**Section 3.** All formal actions of this Council concerning the passage of this Ordinance were adopted in an open meeting, and that all deliberations of this Council, or any of its Committees, which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Codified Ordinances and Section 121.22 of the Ohio Revised Code.

**Section 4.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, welfare and dignity of the residents of the City of Willowick, insofar as it provides for the usual daily operation of the Fire Department during a seasonal period of time where shifting by the part-time hourly members of the Fire Department is often difficult to fully staff; and that it ensures the orderly and uninterrupted efficient operation of the City.

**WHEREFORE**, this Ordinance shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.
