

ORDINANCE NO. 2020 - 39

AN ORDINANCE PROVIDING FOR THE TEMPORARY APPOINTMENT OF RICHARD J. REGOVICH, AS DIRECTOR OF PUBLIC SERVICE OF THE CITY, ESTABLISHING HIS TERMS OF EMPLOYMENT, INCLUDING RATE OF PAY, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Willowick Director of Public Service, Rob Pauley, has retired from the City effective August 26, 2020, and it is detrimental to the health, safety and welfare of the City to be without a Director of Public Service during the process of filling said position on a permanent basis; and

WHEREAS, pursuant to Section 5.3 of the Charter of the City of Willowick, the Council of the City of Willowick has determined that the temporary appointment of Richard J. Regovich as Service Director of the City is necessary to ensure the health, safety and welfare of the citizens of the City of Willowick; and

WHEREAS, the Council desires to establish the terms and conditions of employment for the temporary appointment of Richard J. Regovich as Director of Public Service of the City of Willowick, together with the rate of pay for said position, for a period not to exceed one hundred and eighty (180) days; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOWICK, COUNTY OF LAKE AND STATE OF OHIO:

SECTION 1. That the Council of the City of Willowick hereby appoints Mayor Richard J. Regovich to the position of Director of Public Service of the City of Willowick, on a temporary basis not to exceed one hundred and eighty (180) days, commencing September 1, 2020, or until such time as the position has been filled on a permanent basis, whichever is earlier.

SECTION 2. That Richard J. Regovich, during his temporary appointment to the position, shall be vested with and shall assume the same responsibilities and essential job functions previously exercised by the Director of Public Service of the City of Willowick in furtherance of the City's essential business function.

SECTION 3. That during said temporary appointment, Richard J. Regovich shall be paid compensation for the period beginning September 1, 2020, at the rate of \$1,632.74 per bi-weekly pay.

SECTION 4. That said Richard J. Regovich, while serving as the Director of Public Service of the City, shall respond to the inquiry of Council regarding the services of his Department and such matters that would come within his Department's responsibilities.

SECTION 5. That all ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed.



That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willowick and further, provides for the usual daily operation of a municipal department; wherefore, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
