

ORDINANCE NO. 2014 - 28

AN ORDINANCE AMENDING ORDINANCE 2014-05 TO PROVIDE FOR ADDITIONAL APPROPRIATIONS FROM THE GENERAL FUND (101); POLICE & FIRE CAPITAL IMPROVEMENT FUND (207); STREET IMPROVEMENT LEVY FUND (213); DUI EDUCATION & ENFORCEMENT FUND (217); DRUG LAW ENFORCEMENT FUND (218); E. 330TH STREET IMPROVEMENT FUND (424); FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF WILLOWICK, STATE OF OHIO, DURING THE CALENDAR YEAR ENDING DECEMBER 31, 2014, AND DECLARING AN EMERGENCY.
