

ORDINANCE NO. 2015-21

AN ORDINANCE PROVIDING FOR THE COMPENSATION OF APPOINTED OFFICIALS AND CERTAIN OTHER EMPLOYEES OF THE CITY, REPEALING CERTAIN ORDINANCES AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Willowick, Ohio feels it to be in the best interest of the city and to the orderly operation of all departments of the city to adjust the compensation of appointed officials and certain other employees.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOWICK, LAKE COUNTY, STATE OF OHIO:

SECTION 1. That the Officials and certain other employees listed below shall be paid bi-weekly compensation for the period commencing with the first pay period of 2015 and in accordance with the following existing rates of pay, respectively:

- Fire Chief. the sum of Three Thousand Nine Hundred Forty-eight and 72/100 Dollars (\$3,948.72);
- Police Chief. the sum of Three Thousand Nine Hundred Forty-eight and 72/100 Dollars (\$3,948.72);
- Finance Director. the sum of Three Thousand Seven Hundred Twenty-six and 93/100 Dollars (\$3,726.93);
- Service/Building Director. the sum of Three Thousand Seven Hundred Twenty and 92/100 Dollars (\$3,720.92);
- Recreation Director. the sum of Three Thousand Forty and 39/100 Dollars (\$3,040.39);
- Law Director the sum of One Thousand Nine Hundred Fifty-eight and 01/100 Dollars (\$1,958.01);
- Prosecutor. the sum of Eight Hundred Forty-four and 66/100 Dollars (\$844.66);
- Safety Director the sum of Six Hundred Fifteen and 38/100 (\$615.38);
- Housing Inspector the sum of One Thousand Nine Hundred Twenty-six and 50/100 Dollars (\$1,926.50);
- Payroll/Finance Officer the sum of One Thousand Six Hundred and 61/100 Dollars (\$1,600.61) to One Thousand Seven Hundred Eighty-nine and 91/100 Dollars (\$1,789.91);

- Finance Assistant/Accountant the sum of One Thousand Two Hundred Eighty-two and 77/100 Dollars (\$1,282.77) to One Thousand Six Hundred Sixty-four and 34/100 Dollars (\$1,664.34);
- Senior Citizens Coordinator the sum of One Thousand Five Hundred Twenty and 69/100 Dollars (\$1,520.69);
- Facility/Program Coordinator the sum of One Thousand Four Hundred Ninety and 77/100 Dollars (\$1,490.77);
- Asst. Senior Citizens Coordinator. . the sum of Four Hundred Thirty-four and 68/100 Dollars (\$434.68);
- Channel Programmer the sum of Four Hundred Nineteen and 62/100 Dollars (\$419.62);
- Housing Redevelopment Couns . . . the sum of Four Hundred Sixteen and 32/100 Dollars (\$416.32);
- Public Communications the sum of Eighty-three and 27/100 Dollars (\$83.27);
- Electrical Inspector (P/T) the hourly rate of Twenty-five and 00/100 Dollars (\$25.00);
- Building Inspector (P/T) the hourly rate of Eighteen and 36/100 Dollars (\$18.36);
- Asst. Housing Inspector (P/T) the hourly rate of Fifteen and 30/100 Dollars (\$15.30);

SECTION 2. That all ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 4. That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willowick and further, provides for the usual daily operation of a municipal department; wherefore, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
