#### REPORTS & COMMUNICATIONS FROM THE MAYOR/SAFETY DIRECTOR

The Fire Department study, which outlines plans for the department, was received and distributed to council and civil service members for review. Mayor would like it to go to Safety Committee. The UH Urgent care will be closing as part of their consolidation and will be placed across the street from Lake West Hospital. The Willowick building will be medical campus with

a plan to add more medical services and doctors. There is expected to be a big increase in gas prices through Dominion Energy. The company is proposing instead of raising the cost of gas, raise the cost of distribution by 16-17% and they as contacting PUCO for that information. NOPEC is fighting this idea as residents will get a good rate for gas but will have to pay the distribution fees. Mayor reported the ribbon cutting at Pie Café and the ribbon cutting for Sound Stage and Tavern on Euclid Ave. Dollar Tree is open with a ribbon cutting at a later date, and Aaron's is working on moving to Shoregate. In addition, he announced the fundraiser for Office Maddie on October 21. Toward the end of the meeting, Councilman Malta invited everyone and emphasized the importance of this fundraiser and prayers for Officer Maddie.

#### **GENERAL COMMUNICATIONS & REPORTS – Directors & Officials**

#### Service Director - Todd Shannon

Electronic report submitted. Director Shannon discussed the motions on the agenda for Salt Brine and the Manry repair.

Councilwoman Bisbee inquired about the Manry project regarding the caulking and regarding the statement of any additional damage being billed separately with pictures as proof. Director Shannon noted the caulking is being done in house to save money and regarding the additional damage, until workers get in there to begin repairs, they do not know what may be found.

Ms. Bisbee also inquired an update on the rates. Director Brennan mentioned crews just baited the sewer department, the catch basins at Forest Grove and Arlington Circle.

Councilman Loncala asked if the additional repairs were needed for Manry, would it come back to Council and Director Shannon answered if the amount exceeded \$10,000, would need approval. Mr. Loncala also inquired about warranty for this project, which is 1 year for the workmanship and 10 years for the materials.

Councilman Phares mentioned the light replacement on Vine Street and asked if there is an LED option for those. Director Shannon noted he does not believe the city can retrofit what is already there but would inquire further. Mr. Phares also inquired an update on the lights at Shoreland and Lakewick. The city portion is completed but awaiting CEI to place on their schedule to come out.

#### Recreation Director - Julie Kless

Director Kless reminded of the Halloween program set for October 28 from 1-3. She also mentioned the motion on the agenda to approve the contract for this year's Winter Wonderland program.

Councilwoman Bisbee inquired about the requests regarding remote controlled drone, choppers and planes. Director Kless spoke with Director Landgraf on the subject and as of now there is no ordinance, but informed the resident he could fly as long as there are no big events happening.

#### Fire Chief - Bill Malovrh

No report from Chief Malovrh

Councilman Malta asked that the parking spaces at Shoregate Towers be addressed. Captain O'Connell presented that Ohio Fire Code allows for a fire lane/access way. Minimum clearance for a fire lane is 20 feet wide, 13 ½ inches high. Measurements of the lane at Shoregate from the curb to the end of one of the parking stripes was 21 feet, 4 inches wide. Captain also measured from a car parked on the shoulder to the end of the strip, which yielded 18 feet, 3 inches demonstrating encroachment. Nothing can be done about the parking in this area unless signage is placed noting the same. At that time, not even a handicap-parking placard is allowed to park in this area.

President Koudela asked if the city could force the complex in deeming that area a fire lane and Captain answered yes. Fire Chief does have the authority to change the dimensions of the fire lane; however, he is not permitted to go any smaller than 20 feet.

Marcy Belak, 30901 Lakeshore Blvd., spoke to address Director Brennan regarding the previous apartment inspections at Shoregate Towers. She reported that the head of maintenance

was allegedly informed to disregard current work orders, unless those are an emergency and focus only on the violations prior to the owner's court hearing. She again also addressed the designated parking area for handicap and seniors being occupied by other residents to the Lieutenant Lawrence. Ms. Belak noted that the management informed her handicap parking signs were ordered for the lot.

President Koudela mentioned that the police could cite for illegal parking in handicap areas if there is proper signage. Of the fines imposed, the city does not get all of that money. Director Landgraf believes these fines are afforded to the state. Lt. Lawrence agreed that once the signs are in place, then action can be taken by the officers. Chief Brennan addressed the inspection.

Kenneth Selander 628 Hadley, thanked council for all their help and commended for a job well done.

President Koudela thanked Mr. Selander and Mr. Savoca for their comments.

Steven Arco (sp), 30212 Barjode Rd., expressed his concern for the high-speed traffic down his road, abundance of traffic on 305th St. He also, discussed the previous paving of his road as poor and then asked the holes be repaired.

President Koudela asked of Lt. Lawrence to look into the speeding issue on Barjode. The 305th traffic is an issue with all the construction in the area. Director Shannon noted the traffic study coming for that area in the spring and patching of Barjode. Serena Arco, 30212 Barjode, expressed her similar concerns as well.
