Mayor addressed the accident on Lakeshore and expressed condolences to the family.

The house next to city hall should come down in February or March.

Congratulations were delivered to Councilman Phares and President Koudela for winning their council seats and thanked Councilman Loncala for his time.

All elected officials will be sworn in on January 1, at 11am by the Honorable Judge O'Donnell.

Mayor discussed all the holiday events that took place in December in addition to the fire in Wickliffe where Willowick Fire played a pivotal role in saving the structure. He acknowledged each firefighter individually: Watch Commander Rob Brambrick; FF Brett Fronczek; FF Nate Monroe; FF Tony Fellenstein; FF Ty Leonard and Lt. John Billson.

COUNCIL DISCUSSION OF THE MAYOR'S REPORT

Councilman Mohorcic inquired about a flock camera in the area of the accident. Chief Daubenmire stated not in that area.

Councilman Phares inquired about the funds needed for the house demolition. Mayor responded that the total would be \$18,000-\$19,000 with the Landbank paying half the costs. The city budgeted \$20,000 for the whole project but at most should cost \$9,000-\$10,000 once completed.
