# REPORTS & COMMUNICATIONS FROM THE MAYOR/SAFETY DIRECTOR

Mayor Vanni says he wants to update on a number of things. First, the two renewal levies. One is police and fire capital and the other is sanitary and storm sewer improvements. There will likely be a town hall in October. He will also have information for this on facebook and in his courier article. These are renewals, not an increase. He got the annual report from the City of Euclid. They did stay to their word regarding the 3 year increase. This year 9.09%. It was expected. He would like to have a Finance meeting soon to take a look where we are at in that fund to see if we can absorb some of that. Next year is likely 9.3%. He was just glad they didn't change their projections so we can budget. On the parking lot, they met about a week and a half ago with Service Director Shannon and City Engineer McLaughlin. They wanted to do both parking lots. Haven't gone to bid yet, will do that in the fall, but estimates are over \$1 million. They will bid it out for both but also just for the parking lot. The projection for just the lot is about \$700,000 and we have that pretty much ready to go. If TIF legislation passes tonight, it would give extra also. If they get lot done, next year they do this lot and then opens us up for more funding options. Business wise, good news to report. Sean Brennan and the Mayor met with the owner of the old Willowick Café. It is going really well, maybe 90 days out. Going to be a highscale coffee shop, lunch/dinner restaurant. Reminds him of something in DTW. Going to be something nice, we don't have anything like that. Alfredos Italian Market got their permits today. On pace for maybe beginning of 2026. Chopsticks Cuisine has been in the works for nearly 2 years now and they should open soon. Pashka is investing in the community with building improvements, over \$300,000 in the building. Last week he talked to the company that owns the Rite Aid building. They are working on the property but still no update on a business going in there yet. Lastly, he thanks Julie and the Rec Department for a super busy summer full of great events.

#### COUNCIL DISCUSSION OF THE MAYOR'S REPORT

Mr. Malta asks where Chopsticks is going?

Mayor says old Taco Bell.

Malta any word on old Walkers?

Mayor says still waiting. They're working on the property.

Ms. Koudela reminds everyone that the proposal for increased rates, initially the first year rate was even higher... 15-16%. We told Euclid's Council that this was a huge burden for our City and residents. We don't like paying the sewer cost, but Euclid is facing the same issues we are facing but in a different way just like our residents. She thanks the City of Euclid for hearing our concerns and taking their recommendation to try to even out the increase so it's not such a huge hit.

Mr. Phares says this is a perfect example of this Administration going to bat for the residents. He is glad that Ms. Koudela brought it up.

Ms. Koudela says she feels it created a better working relationship between Willowick and Euclid. She jokes their Service Director is almost as great as ours.

Mayor says yes, she's 100% right.

Mr. Malta says they were told Shoregate Towers was sold. Any input?

Mayor says they did meet with the prospective owners last week. They won the bid, but nothing is finalized yet. It was a good first meeting.

Ms. Antosh says when that deal goes through and closes are there strict guidelines for the repairs? Who sets that?

Law Director Gwirtz says that was part of what the meeting was about. They will likely be coming to BZA for Variances due to the scope of the project and also to discuss the escrow account. What they have in mind is very reasonable. We are talking possibly double digit in millions of repairs that they need to do.

Mr. Mohorcic says to clarify, we require that they carry 1.5x?

Gwirtz says no, they already started point of sale inspection. Whenever there are violations, any repairs not made at the time of transfer, an escrow account is required. The thought would be they have to show some sort of potential to have that sort of money.

# GENERAL COMMUNICATIONS & REPORTS – Directors & Officials

## Service Director - Todd Shannon

Todd Shannon says it was a pleasure working with Cheryl. Good luck. He submitted his report electronically. He has a couple items on the agenda. One for a federal grant to evaluate traffic conditions throughout the City. Safety intervention grant is for a new lift that they discussed during budget. Another section of Lakeshore will be torn up for waterline work.

Ms. Antosh asks are they doing that whole stretch at once?

Mr. Shannon says they'll know more soon but he anticipates the whole thing.

Ms. Koudela says she wasn't thrilled with the contractor that did the work. She knows that he doesn't have much control over that. The traffic control was terrible, maybe he can pass that along. On a different topic, they had Safety Committee meeting earlier. Previously there was discussion about 305 on the freeway, headed South, extending that back to Oakdale as a straight only lane?

Mr. Shannon says there are multiple layers to that question. The grant he just talked about will take a long hard look at that intersection. Ultimately they do not control that intersection, Wickliffe and ODOT do. They are paving it next year. It's not as easy as changing a few paint lines.

## Recreation Director - Julie Kless

Julie Kless says they had their car show on Sunday and had over 110 cars there. She thanks the department for all their help with that. The fall/winter guide is up on the website. Monday September 8th will start registrations. Repairs to the pickleball courts are looking good. She says she has had a wonderful time working with Cheryl.

# City Engineer – Tim McLaughlin

Tim McLaughlin emailed his report. There are two items on the agenda. He has had the privilege to work for multiple cities and Cheryl is truly special. It has been a pleasure. She helped him to do his job better.

## Finance Director - Cheryl Benedict

Finance Director Benedict says there are several items on the agenda, most of which are housekeeping items. They received the second half property tax collections and did receive the reimbursement. She notices that Dawn and Joe are here tonight and thanks them for coming. They are a great asset to the City. She also reports they have a clean audit again.

Mr. Malta says she was paid a lot of compliments and she deserves everyone one of them. He says no one has called her a GOAT and that's what she is (Greatest of All Time).

Ms. Koudela asks if Dawn or Joe would like to make a comment.

Dawn says Cheryl has been amazing. She respects her so much and always looks to her for guidance. She has always been very fair and always knows all the answers. She is going to miss her so much. Dawn jokes Cheryl rescued her from her previous employer and brought her here.

Cheryl says she will miss her as well.

Joe thanks Cheryl for the opportunity to be a part of the team. He has worked with many people in his career and he wishes he had met her 15 years ago. He sees so much consistency in the department and they will try to keep it going.

#### **Law Director** – Mandy Gwirtz

Mandy Gwirtz wishes Cheryl well. No formal report, but open for questions.

#### Police Chief - Rob Daubenmire

Chief Daubenmire says he appreciates Cheryl. His transition from Lt. to his current position would have been a lot more difficult without her guidance. He submitted his report electronically.

## Fire Chief - Bill Malovrh

Chief Malovrh congratulates Cheryl. He will be submitting his report tomorrow.

# Chief Housing/Zoning Inspector – Sean Brennan

Sean Brennan submitted his report as well. He jokes he is jealous of Cheryl and wishes her good luck and fun.

Mr. Malta says there is an area in Ward 3 where there is a mouse/rat problem. Unlike other cities, we have Sean Brennan. He called Sean at 5 to 4:00 on a Friday night. When Sean answered, he immediately came to tackle the problem. Without his input, it may have grown worse.

Mike Bowen, 472 E 319, says how things have changed. His question is, do we know why the portion of the parking garage at Shore gate Towers collapsed? Back in '64, that was a big dump. He remembers throwing rocks there. He also helped push a car over the edge. Do we know why it collapsed?

Rose Allen, 30951 Lakeshore, says she thinks Willowick is probably the best location for someone to live in Northeast Ohio. She walks this community every day and feels safe. However, we have an issue with people who walk. Right now, the crossing lights for pedestrians at Vine/Lakeshore are only partially functioning. Why is it taking so long to get them repaired? She feels she should not have to walk over to the Eastern side to safely walk to the post office. By shutting down those crosswalks, are you trying to prevent people from crossing? How soon until they are repaired?

Jean Bowen, 472 E 319th, asks if the guy who owned Shoregate Towers disappeared off the map? What is happening to him? Fines? Jail? Also, she is glad to hear about the situation with 305, but will there still be a turn lane for N. Marginal?

Ms. Koudela has Mr. Shannon answer Ms. Allen regarding the crosswalks. A couple months ago CEI replaced a pole that was damaged with an accident. Unfortunately that damaged the intersection. The second delay is getting a company in here to make those repairs. They are scheduled to be here in 2 weeks. This was not intentional. The intersection is running on a temporary basis at the moment.

The Mayor says he feels her frustration. Todd probably even more. Hopefully in 2 weeks... we are getting close to the end. It is hard because we have to wait for the company to come out. Todd stayed on it and kept working to get it repaired.

Ms. Koudela and Mr. Shannon say the results of the year long traffic study will help make decisions like that. Regarding Shoregate Towers, she directs to Chief Malovrh.

Malovrh says he never got a full result of the cause of collapse. Mayor agrees, no official report of what caused it. There are rumors out there.

Ms. Koudela says the owner is still in court?

Gwirtz says yes the foreclosure is still pending in Lake County Court of Common Pleas.

Ms.Koudela says the City did pay for search and rescue as well as the fencing there. That money did come back on the most recent collection.
