Hearing of Claims:

Linda Beil: 607 Carrington Ct, Willowick, OH 44095

- Resident attended the meeting. Seeking a credit for repairs when her water back up pump failed causing water to continuously run in the sump pump while the other pump was working and pumping the water out to the sewer.
- This does not meet the criteria for a sewer adjustment.
- Committee voted No. Monica Koudela-No, Dave Phares-No, Natalie Antosh-No

Donald & Patti Iscrupe: 29300 W. Willowick Dr., Willowick OH 44095

- Resident attended the meeting. Seeking a \$400.00 credit for when hot water pipe broke under the slab floor of kitchen during the cold spell in Dec 2022. Had to move out of the house during construction because they found asbestos through out 1st floor that had to be removed. Did submit claim to insurance company for all the repairs that needed to be done.
- The broken pipe under the slab does meet the criteria for a sewer adjustment. Cheryl Bendict explained how she came up with a sewer credit of \$188.32 that will be credited to them.

- Resident unable to attend the meeting. Seeking a sewer credit proportionate to the \$9.54 water credit granted by Lake County Department of Utilities. Does not know reason for high water/sewer bill. Did submit an invoice from Formica Plumbing showing replacement of kitchen faucet and adjustment of toilet flapper.

- Seeking \$4,000.00 for car repairs and suffrage, from running over a piece of metal that fell off a Willowick City dump truck that was filled with scrap materials. He was asked why he hasn't gotten it repaired and he said he doesn't have the money he is poor. When asked if he called his insurance company, he said the insurance company told him no. When asked why he didn't take pictures of his car with the metal under it or the damage to his car at that time, he said he was in a hurry taking pictures of the city truck and employees. He said he took pictures of it at the repair shop. He said he can't drive the car now and can't go to work. He was asked what kind of condition the car was in after the metal got stuck under his car, he said drove it to Affordable Auto service in Wickliffe for estimates and then drove it home and parked it. He was asked if all 4 tires were damaged and he said he didn't know. That the repair shop said you can't replace 1 tire; you need to replace all 4. When asked if he filed a police report, he stated no he is scared of the police. He claims the metal piece went under the right front wheel and got stuck. The repair shop states estimate is for the left front lower control arm. He said he doesn't know what damage it did. He told the repair shop what happened. Asked if he had any damage to the tires and he said he had to put air in his front left tire. The tire that the piece of metal was stuck under. He said he was following the city truck a vehicle length at ten miles per hour. He said he was not texting because it is unsafe.
